2. The bidders should submit their E-bid as per KPPRA Notification No.SRO (14)-Vol/1-24/2021-22,dated 10-05-2022.
3. All Bidders are required to have valid Registration with Khyber Pakhtunkhwa Revenue Authority established under the Khyber Pakhtunkhwa Finance Act 2018 (Khyber Pakhtunkhwa Act, XXI of 2013)
4. The Competent Authority reserves the right to accept/reject any or all bids at any time prior to acceptance of a bid as per Para 47(i) of KPPRA Rules 2014 by assigning cogent reason.
5. The interested Firms/Contractors may obtain clarification regarding bid solicitation documents during office hours on any working day from the office of Executive Engineer, Dir Irr: Divn: Timergara and Swat Irrigation Division-I, Swat.
6. Venue of Bids opening is office of the Chief Engineer (North) Irrigation Department Warsak Road Peshawar however, the Contractors must prepare their CDR's i.e. 2% Earnest Money and Additional E/Money (if any) in shape of call deposits only in the name of Executive Engineer, Dir Irrigation Division, Timergara and Swat Irr: Divn:-I Swat respectively and should ensure its submission with their bids. In case of failure their bids would be rejected and punitive action should be initiated against the defaulter as per KPPRA Act / Rules.
7. In case of identical lowest responsive bids the successful bidder would be decided through Toss.
8. 2% Earnest Money + Additional Security of 1st, 2nd and 3rd would be retained by concerned Executive Engineer till the approval/acceptance of each work by Competent Authority.
