TERMS AND CONDITIONS: -

- 1. Financial Bid should be submitted online / electronically and CDR (in original) & other relevant documents should reach in this office in sealed envelope on or before the closing date and time.
- 2. Electronic Bids will be displayed online on E-Bidding System after 30 Minutes of closing time in the presence of bidders/their representatives who choose to be present.
- 3. The contractors quoting their bids up to a limit of 10% below on Engineer Estimate shall submit bid security @ 2% only of the Engineer estimate till the closing time.
- 4. The contractor quoting their bids more than 10% below up to 20% below on Engineers Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favor of Government and the second lowest bidder and so on will be considered accordingly.
- 5. [Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's estimated cost equal to the differential amount of submitted bld and Engineer's Estimate along with detailed rate analysis], in case of more than 20% below bids, if the bid is not accompanied along with detailed rate analysis]. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such nonresponsive bld shall be forfeited in favor of Government and the 2nd lowest bidder and so on will be considered accordingly.
- 6. In case detailed rate analysis submitted with the bids is in view of this division, not convincing, the competent authority may declare such bid as nonresponsive without any forfeiture of bld securities and record reasons thereof.
- 7. The bidders are required to quote their rates (electronically) ABOVE/BELOW/AT PAR for both priced BOQ/Engineer Estimated based on MRS 2022 and NSI Items as well. Only Two Digits after the decimal point shall be considered for evaluation purpose.
- 8. Any bidder who provides incorrect information shall stand disqualified and de-barred.
- 9. Time allowed for the completion of the work as specified in the NIT shall start from the Issuance of Work Order.
- 10. Electronic Bids validity period is 90-Days.
- 11. Successful, bldder should sign the agreement with the department within Twenty-one (21) days after issuance of Work Order.
- 12. Call deposit of scheduled Banks shall be acceptable.
- 13. If the evaluated electronic bid costs of two or more than two bidders are equal the successful bid will be declared through open bowl technique.
- 14. The employer has the authority to reject any bid or all the bids assigning cogent reasons.
- 15. Bid security of the 1st, 2nd and 3rd lowest bidders of each work will be retained by the department till the approval of bid.
- 16. The successful bidder shall be subjected to all admissible taxes including stamp duty, service charges, sales tax and any other at prevailing rates.
- 17. All others rules of KPRA and Government of Pakistan will be applicable on the procurement process.
- 18. All bidders are required to registered with the Khyber Pakhtunkhwa Revenue Authority (KPRA) established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI or "2013), for works, consulting and non-consulting services as listed in Schedule-II of the act ibld.
- 19. Non-refundable bidding entry fee @0.03% of tender cost and stamp duty in Shape of Call Deposit separately may be furnished (in original) to this office as recommended by the Sub-committee of the cabinet notified vide Section Officer (Confidential) Chief Minister's Secretariat Khyber Pakhtunkhwa Peshawar No. SO(C)/CMS/KPK/2020-21 dated: 21-04-2021.
