

- All the conditions / instructions given in the bidding documents shall be applicable on all competitive bidders.
- The bids will be valid for one hundred & twenty days (120) from the bids opening.
- The bid security upto 3rd lowest bidder will not be released till approval of tender by the competent authority.
- Call Deposit of Scheduled Banks shall be acceptable. No Bank cheque or pay order shall be acceptable.
- All the bidders are requested to download the bidding documents from the KPPRA website / www.irrigation.gkp.pk.
