TERMS AND CONDITIONS:

- Bid Soliciting Documents containing Instructions to Bidders, Terms & Conditions, advertisement for Notice Inviting Bids and required forms to be filled by the bidders can be downloaded from the official website of Irrigation Department Khyber Pakhtunkhwa (www.irrigation.gkp.pk).
- The bidders should submit their E-bid as per KPPRA Notification No.SRO(14) Vol/1-24/2021-22, dated 10/05/2022. The contractor quoting their bids more than 10% below upto 20% below on Engineer's Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated Cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the second lowest bidder and so on will be considered accordingly.
- Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's estimated cost equal to the differential amount of submitted bid and Engineer's Estimate along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Government and the 2nd lowest bidder and so on will be considered accordingly.
- All Bidders are required to have valid Registration with Khyber Pakhtunkhwa Revenue Authority established under the Khyber Pakhtunkhwa Finance Act 2018 (Khyber Pakhtunkhwa Act, XXI of 2013)
- The Competent Authority reserves the right to accept/reject any or all bids at any time prior to acceptance of a bid as per Para 47(i) of KPPRA Rules 2014 by assigning cogent reason.
- The interested Firms/Contractors may obtain clarification regarding bid solicitation documents during office hours on any working day from the office of the concerned Executive Engineer.
- Venue of Bids opening is office of the Superintending Engineer Swat Irrigation Circle, Gulkada Saidu Sharif District Swat, however, the Contractors must prepare their CDRs i.e. 2% E/Money and Additional E/Money (if any) in the name of concerned Executive Engineer and ensure accompany with their bids. In case of failure their bids would be rejected and punitive action would be initiated against the defaulters as per KPPRA Act/ Rules.
