TERMS AND CONDITIONS

- 1. Technical Design should be based on Hydraulic Parameter of the scheme provided in the bidding documents and rates should be quoted accordingly in the financial bid. Technical bid will be opened on the date and time mentioned above by the bid opening committee in the office of the undersigned in the presence of bidders. Specification and design parameter of pumping machinery are given in the bidding documents.
- Electronic bidding will be online through E-bidding system. BOQ can be filled online and downloaded from the official website of Irrigation Department i.e., www.irrigation.gkp.kp, moreover; a complete set of bid solicitation documents may be obtained on submission of written application one-day prior to the opening date from office of the undersigned on cash payment (nonrefundable) fees of Rs. 2000/- otherwise bid submitted without these documents will be considered as non-responsive.
- 3. For Additional Security in case abnormally low bids KPPRA Notification S.R.O. (14)/Vol: 1-24/2021-22, Dated 10th May, 2022 shall be enforced.
- 4. The procuring entity may reject all bids at any time prior to the acceptance of a bid, the procurement entity shall upon request communicate to any contractor who submitted a bid, the ground for rejection of all bids as per KPPRA Rules 47(1).
- 5. Pre-Bid meeting will be held on **10-11-2022** at 11:30 AM the prospective bidders may attend the pre-bid meeting.
- 6. Date of opening of financial bid will be announced after approval of technical bid from the competent authority and will be communicated to all bidders accordingly.
- 7. Technical and Financial bids, if received to the office of the undersigned unsealed will be rejected.
- 8. Tender shall be opened on advertised date and time in the presence of bidders or their representatives who may like to attend the session, in case of any unforeseen reason, public holiday, unrest or force majeure on the bid submission / opening date, the tender shall be opened on the next working day at the same place and time.
- 9. All federal and provincial duties / stamp duty / taxes including sales tax will be recoverable as per directive of the Government issued from time to time.
- 10. If any document submitted along with bids is found false / bogus the registration of the Contractor / Firm shall stand cancelled / black listed.
- 11. Electronic bids will be valid for Ninety (90) days from the closing date of bids.
- 12. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority.
