







TERMS AND CONDITIONS

1. Bid solicitation documents, containing all the terms & conditions & other relevant instruction for works can be downloaded from the Department & or KPPRA Websites (www.irrigation.gkp.pk) (www.kppra.gov.pk).
2. Electronic bidding shall be done on "above / below system" on BOQ/Engineers estimate.
3. All bidders are required to have registration with Khyber Pakhtunkhwa Revenue Authority.
4. The bidder shall submit 02% bid security, of the estimated cost as mentioned above, in the shape of deposit at call (Original) along with their bid before closing date and time, i.e (12:00pm) & opening time (12:30pm).
5. Notification issued by KPPRA pertaining to procurement process issued from time to time shall be applicable and notification No.S.R.O (14)/Vol:1-24/2021-2022, dated.10.05.2022/6058-71 is part of the Bid solicitation document.
6. If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw/toss.
7. Bid security of 1st, 2nd and 3rd lowest bidders will be retained by the employer till the approval of bids by the competent authority.
