- 4. All bidders are required to have valid registration with Khyber Pakhtunkhwa Revenue Authority.

- 5. The bidder shall submit 02% bid security of the estimated cost as mentioned above, in the shape of deposit at call (Original) enclosed along with their bid before closing date and time in the name of Executive Engineer, Hydrology Irrigation Division Peshawar.
- 6. Notifications issued by Khyber Pakhtunkhwa Public Procurement Regulatory Authority pertaining to procurement process issued from time to time shall be applicable.
- 7. If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw/toss.
