- 3. All the bids received shall be opened and evaluated in the manner prescribe in the bidding document.
- 4. The bidder shall submit their Bids on the following address "Superintending Engineer Peshawar Irrigation Circle Peshawar" only through reliable courier service on or before the dead line along with required document as per details mentioned in bid solicitation document. The affixed labials of the courier service provider may be authenticated for tracking before opening. Fake courier delivery shall be processed as per the law and would not be considered.
- 5. All bidders are required to have valid registration with Khyber Pakhtunkhwa revenue authority.
- 6. The bidder shall submit 02% bid security, of the estimated cost as mentioned above, in the shape of deposit at call (Original) along with their bid before closing date and time in the name of Executive Engineer Tubewells Irrigation Division Peshawar.
