2. Electronic bidding shall be done on **"Above / Below system"** on BOQ / Engineer's estimate.
3. The bidder shall submit their bids on the following address **"Superintendent, O/O Peshawar Irrigation Circle, Peshawar, Warsak Road, Peshawar"** only through reliable courier Service on or before the deadline along with required documents as per details mentioned in Bid Solicitation Documents. The affixed labels of the Courier Service provider may be authenticated for tracking before opening. Fake courier delivery shall be processed as per the law and would not be considered.
4. All bidders are required to have valid registration with Khyber Pakhtunkhwa Revenue Authority.
5. The bidder shall submit 02% bid security of the estimated cost as mentioned above, in the shape of deposit at call (Original) enclosed along with their bid before closing date and time in the name of Executive Engineer, Peshawar Canals Division, Peshawar.
6. Notifications issued by Khyber Pakhtunkhwa Public Procurement Regulatory Authority pertaining to procurement process issued from time to time shall be applicable.

BOQ alongwith photo copies of the following i.e Pakistan Engineering Council Registration for the year 2022-2023, Enlistment with Irrigation Department with renewal for 2022-2023, Registration with Khyber Pakhtunkhwa Revenue Authority, NIC, ownership documents, Income Tax/NTN Certificate & other mandatory documents shall be required for bid

evaluation/approval purposes of the concerned Firm/Contractor after E-bidding Procedure the bid shall not be considered for evaluation if short coming etc: is detected.

8. If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw/toss.
