- The bidder shall submit their bids through leading courier service on or before the deadline along with required documents as per detail mentioned in bid solicitation documents.
- 3. Electronic Bid shall be done on "above / below" System on BOQ / Engineer estimate.
- All the participating firm will be evaluated as per Criteria duly included in Bid Solicitation documents and the firms who
 failed in the criteria will be considered non-responsive.
- 5. Venue of Bids Opening is office of the Executive Engineer CRBC Irrigation Division DIKhan.
- If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw / toss.
- 7. Two percent (02%) Bid Security/Earnest Money + Stamp duty + Tender Fee of the Estimated cost from the account of firm/bidder/ contractor who submits the bid must be accompanied with the tender document / Quotation through any scheduled bank in favor of Executive Engineer, CRBC Irrigation Division, DIKhan. Failure to submit the 2% CDR will lead to rejection of the bid.
- Firm must have successfully completed Solar System i/c Pumping Machinery along with accessories, having more than 0.5 cused discharge in past 3 years.
- 9. The bidders who quote their bids / rates more than 10% below on Engineer's Estimate shall submit additional security as per KPPPRA Notification No. S.R.O (14) / Vol: 1-24/2021-22, dated 10-05-2022.
- 10. Bid security of the 1st, 2nd and 3rd lowest electronic bidder for the specific work may be retained by the Department till one week after issuance of LOA.
- 11. All the bidders / firms must be register with the Khyber Pakhtunkhwa Revenue Authority.
- 12. All the prevailing KPPRA Acts / Rules and other Government Notification will be applicable, issued from time to time.
- 13. Funds release depends upon policy of Provincial Government; hence payment will be made accordingly. Bidder / Contractor agreeing with the financial constraints in respect of payment etc are at liberty to participate in the instant E-Bidding as no claim whatsoever will be entertained in this regard.

- 15. The Last date & time for Submission of the Bid along with relevant documents is 30-04-2023 up to 12:00 PM which will be opened on the same day at 12:30 PM in the office of the undersigned in presence of Contractor and their representatives who wish to attend.
