- 2. Firms are requested to deposit bid security in shape of CDR@2% of estimated cost in favor of Superintendent (Admn)/DDO Irrigation Department.
- 3. Successful bidders shall submit performance guarantee @ 10% in shape of CDR/Bank draft of the total purchase/work order after receipt.
- 4. Details/Bidding documents can be obtained @Rs.3000/- from the Care Taker of Irrigation Department during working hours on any working day till-Date,16/09/2024 before 1200 hours.
- 5. Bidders can apply to all the items collectively as well as to a specific category of their interest with lowest possible rates in accordance with the specifications.
- 6. The bids shall reach to the office of the Superintendent (Admn)/DDO) Irrigation Department through registered Dak or Courier Services or by hand on or before <u>Date till 16/09/2024, 1200 hours.</u>
- 7. The bids shall be opened by the Procurement Committee in the presence of representatives of the bidders who chose to attend the meeting on Date 16/09/2024 at 1400 Hrs in the conference room of Irrigation Department.
- 8. Late bids received will be treated as non-responsive.
- 9. Bidders are requested to quote their rates strictly in accordance with items provided otherwise their bid shall be treated as non-respective.
- 10. The procuring entity reserve the right to reject any or all bids as per provision contained in Rule 47 of KPPRA procurement Rules 2014.
- 11. All Federal & Provincial duties / taxes applicable will be recoverable as per existing instructions of Government issued from time to time.
- 12. The Procuring entity can change the quality & quantity of items as per their requirement and budgetary provision.
- 13. Bidders are requested to offer most competitive lowest rates of the items inclusive of all taxes, as negotiations on quoted rates are not allowed under the rules
