## TERMS AND CONDITIONS:

- 1. The interested Contractors / Firms are required to provide the Bid Security in Original @ 2% of the estimated cost in the shape of Call Deposit and an Additional Bid Security in Original @ 8% of the estimated cost in the shape of Call Deposit from scheduled banks, if the bidder quotes his rate further below than 10% on the engineer's estimate.
- 2. The Financial Bid shall be submitted electronically through E-Bidding System of Irrigation Department, not later than above specified date & time.
- 3. Bid Soliciting Documents containing Instructions to Bidders, advertisement for Notice Inviting Bids and required forms to be filled by the bidders can be downloaded from the official website of Irrigation Department Khyber Pakhtunkhwa (www.irrigation.gkp.pk).
- 4. Bidders shall provide copy of CNIC, Enlistment with Govt: of KP, Pakistan Engineering Council & KPRA.
- 5. Electronic Bidding shall be done on "Above / Below System" on BOQ / Engineer's Estimate, based on the MRS applicable. Only two digits after the decimal point shall be considered for evaluation purpose.
- 6. The contractors quoting their bids up to a limit of 10% below Engineer estimate shall submit bid security @ 2% only of Engineer Estimate.
- 7. The contractors quoting their bids more than 10% below upto 20% below on Engineers' Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated Cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the second lowest bidder and so on will be considered accordingly.
- 8. Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's estimated cost equal to the differential amount of submitted bid and Engineers' Estimate along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forficited in favour of Government and the 2nd lowest bidder and so on will be considered accordingly.

- 9. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
- 10. All the Bidders are bound to follow the instructions content KPPRA Notification No.S.R.O.(14)/Vol:1-24/2021-22, dated 10-0-2022
- 11. All Bidders are required to have valid Registration with Khyber Pakhtunkhwa Revenue Authority established under the Khyber Pakhtunkhwa Finance Act 2018 (Khyber Pakhtunkhwa Act, XXI of 2013).
- 12. Electronic Bids shall be submitted electronically on or before the fix date / time.
- 13. Any Bidder who provides incorrect information shall stand disqualified and will be debarred.
- 14. Call Deposit of schedule Banks shall be acceptable. No Bank Cheque or Pay Order shall be acceptable.
- 15. The Competent Authority reserves the right to accept / reject any or all bids at any time prior to acceptance of a bid as per Para 47(i) of KPPRA Rules 2014.
- 16. Bids must be received in the relevant office through courier services or TCS agencies by hand submission will not be acceptable.
- 17. Bid Securities of 1st, 2nd & 3rd lowest bidders shall be retained till approval of the bids by the Competent Authority.
- 18. All the prevailing KPPRA Act / Rules and other Government Notifications issued will be applicable.
- 19. In case of identical lowest responsive bids, the successful bidder would be decided through toss.
