

TERMS AND CONDITIONS FOR E-BIDDING:-

- 1/ Bids shall be submitted electronically through E-Bidding wherein all the documents are available on the website of the department www.irrigation.gkp.pk as well as "KPPRA" Website.
- 2/ Bid Solicitation documents should contain mandatory requirements to be fulfilled, in order that bidders to be eligible to participate otherwise their bids will be rejected.
- 3/ Venue of bids opening is Marwat Canal Division Bannu.
- 4/ The bidders are required to quote their rates above or below on BOQ both on MRS as well as non MRS components.
- 5/ The additional security will be deposited by the successful bidder strictly following the KPPRA rules noticed vide No.SRO (14) Vol: 1-24//2021-22,dated 10-05-2022.
- 6/ If the evaluated electronic bid costs of two or more than two bidders are equal, then the successful bidders will be declared through toss or best evaluated value of bidders, as deem fit by the procuring entity.
- 7/ The competent authority reserves the right to accept / reject any or all bids any time prior to acceptance of a bid as per Para 47(i) of KPPRA rules 2014, quoting cogent reasons.
- 8/ Bid security of the 1st, 2nd and 3rd lowest electronic bidder for the specific work will be retained by the Department for at least one week after issuance of letter of acceptance to the successful bidder.
- 9/ All the bidders/Firms must be registered with the Khyber Pakhtunkhwa Revenue Authority.
- 10 All the prevailing KPPRA Acts/rules and other Govt: notification will be applicable, issued from time to time.
- 11 Release of funds depends upon the policy of Provincial Government; hence payment will be made accordingly. Bidder/Contractor agreeing with the financial constraints in respect of payment etc: are at liberty to participate or otherwise in the instant E-bidding as no claim what so ever will be entertained in this regard.
- 12 The bid will be received on 08-08-2024 up to 12:00 Noon and will be opened on the same date at 12:30 PM, and if due to any reason a "Public Holiday" is declared by the Govt: on the tender opening day, then opening of tenders will be processed on the next working day and time under the same terms and conditions.
