- The interested Contractors / Firms are required to provide Technical Proposal comprising information regarding Experience, Personnel Capabilities, Financial Status, Equipment Capabilities and other relevant information as explained in the Bid Soliciting Documents (one original + one copy) in sealed envelopes & the Financial Proposal in separate envelope containing their CDR's i.e. 2% Earnest Money in shape of call Deposit and Additional Bid Security (if any) as per Kppra Notification No.S.R.O.(14)Vol: 1-24/2921022, dated 10-05-2022, in the name of Executive Engineer, Swat Irrigation Division-I and should ensure its submission with their bids. In case of failure their bids would be rejected and punitive action should be initiated against the defaulter as per KPPRA Act / Rules.
- The Financial Bid shall be submitted electronically through E-Bidding System of Irrigation Department, 2. not later than above specified date & time.
- Bid Soliciting Documents containing Instructions to Bidders, Technical Evaluation Criteria, advertisement 3. for Notice Inviting Bids and required forms to be filled by the bidders can be downloaded from the official website of Irrigation Department Khyber Pakhtunkhwa (www.irrigation.gkp.pk).
- The Financial bids of the qualified bidders approved by the Competent Authority shall be opened by the 4. notified committee after 10 days of uploading of evaluation on the Irriagtion Department website.
- The Bids shall be quoted on "%age Above / Below System" on BOQ/ Engineer's Estimate 5.
- The Competent Authority reserves the right to accept / reject any or all bids at any time prior to acceptance of 6. bid as per Para 47(i) of KPPRA Rules 2014.
- Call Deposits of only scheduled Banks shall be acceptable. No Bank Cheque or Pay Order shall be 7. acceptable.
- All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority (KPRA).
