MINUTES OF THE PRE-BID MEETING HELD ON 17-12-2024 AT 02:00 P.M.

The Notice Inviting Tender (NIT) for the Single Stage Two Envelope system was prepared for the mentioned works from prospective bidders/contractors registered with PEC in the relevant category. The NIT was forwarded to the Director Information Department, Khyber Pakhtunkhwa, via letter No. 64/3-S, dated: 03-12-2024 and was published in Daily Mashriq and Dawn Newspaper Vide INF(P) # 3283/24, Dated: 07/12/2024.

The meeting commenced with the recitation of the Holy Quran.

Discussion Points:

1. Request for Early Release of Call Deposits

Contractors and firms requested the release of call deposits soon after the opening of Financial E-bids. They specifically asked that the call deposits of contractors except the 1st, 2nd, and 3rd lowest bidders be released immediately after the Financial E-bids are opened.

<u>Clarification:</u> The Executive Engineer, Irrigation Division Bajaur, clarified that call deposits for all contractors, except for the 1st, 2nd, and 3rd lowest bidders, can only be released after the completion of both Technical and Financial evaluations and publication of the evaluation report on the Irrigation and KPPRA websites.

2. Timeframe for Technical Evaluation

The contractors requested that the Technical Evaluation be completed as soon as possible.

Clarification: The committee assured the contractors that efforts would be made to finalize the Technical Evaluation within the timeframe, as per the prescribed rules.

3. Clarification on Eligibility Criteria

Contractors inquired about the eligibility criteria.

<u>Clarification:</u> It was explained that the eligibility criteria are clearly outlined in the approved/uploaded Standard Bidding Documents (SBDs) and must be adhered to and also explained the mandatory criteria.

4. PEC Codes and Tender Process

Contractors expressed reservations about the PEC codes and requested their removal. They also proposed changing the tendering process from Single Stage Two Envelope to Single Stage Single Envelope.

<u>Clarification:</u> The Executive Engineer explained that the PEC codes are mandatory for ensuring the execution and quality of work. Deleting these codes is not possible as it would compromise project standards. Additionally, it was emphasized that the Single Stage Two Envelope system is essential for ensuring technical and financial competitiveness. The forum accepted the stance of the Executive Engineer.

It was further explained that bids must be properly compiled, ordered, and complete in all respects as per the conditions set in the NIT and Standard Bidding Documents.

5. Submission of Bidding Documents

The participants requested that a single bidding document be allowed for all bids.

<u>Clarification:</u> It was clarified that duly signed bidding documents must be submitted separately for each individual bid.

6. Bid Compliance and Completeness

Contractors were reminded to ensure that all submitted bids are complete, legible, and compliant with the requirements set forth in the NIT and SBDs. Non-compliance may lead to the disqualification of bids.

Conclusion:

The meeting concluded with a vote of thanks to and from the procurement committee.
