Terms & Conditions:-

1. All bidders are requested to scan & upload their Bids (CDR'S & Rate on BOQ / BID Documents along-with relevant documents in one PDF file) and submit through EPADS (<https://kp.eprocure.gov.pk/>) before the mentioned system closing time. Any bid received without uploaded required documents i.e (copy of CNIC, Enlistment with Govt: of KP, Pakistan Engineering Council, Active KPRA status & Active FBR status and rate analysis (if required) will be treated as NON-RESPONSIVE. Incomplete/conditional bids with unattested cutting/overwriting/disfiguring uploaded shall be considered as NON-RESPONSIVE. No hard form / print out of bid are required / acceptable except CDR/call deposit.
2. **The excavated silt may be disposed off at suitable distance to avoid its fallback to canal and to avoid its environmental effect.**
3. Bid solicitation documents for the bidders contains requirement for the eligible bidders and other important terms and conditions. Bid solicitation documents i/c instructions to bidders can be downloaded from Irrigation website <http://www.irrigation.gkp.pk/> as well as KPPRA website. Mandatory conditions as per solicitation bidding documents (SBDs) will be adhered.
4. Complete detail of bid security in shape of CDR i.e Bank Name, CDR number(s)/ date(s) prepared in the name of Executive Engineer Buner Irrigation Division Buner must be submitted (before the expiry time) electronically along with E-bid on the EPADS as well as in **sealed envelope** as per KPPRA notification No.S.R.O (14)/Vol:- 1-24/2021-22/6058-71 dated 10.5.2022 & Notification No.S.R.O (29)/Vol:1-40/2025-26/699-711 dated 29.10.2025. No Bank cheques or pay order shall be accepted.
5. Electronic bidding shall be done on "above/below system" on BOQ/ Engineer Estimate based on the MRS/ NSI where applicable. Only two digits after the decimal points shall be considered for evaluation purpose. In case of same rates quoted by the contractors, the lowest bidder shall be decided **through draw/toss**.
6. The employer has the authority to reject any bid/ all the bids by assigning cogent reasons.
7. All the bidders/Firms must be register with the Khyber Pakhtunkhwa Revenue Authority. All the prevailing KPPRA Acts/ rules/ updated instructions/ notification and other Govt: notifications will be applicable issued from time to time.
8. All the Contractor/ Firms shall pay Govt: taxes including Income Tax, Sales Tax, Professional Tax, Stamp duty etc as per Govt: notifications circulated from time to time.
9. Successful bidder should sign the Agreement with the Deptt: within 28 days after receipt of acceptance letter.
10. The additional security shall be released to the contractor in 04 installment i.e Ist installment of 25% to be released upon completion of 25% of the project. 2nd installment of 25% upon completion of 50% of the project. 3rd installment of 25% upon completion of 75% of the project and 4th installment of 25% after 100% completion/ handing over the project.
11. All such efforts conspire to curtain making shall be considered as violation of rules 44 and shall be attributed toward mis-procurement under rule 54 procurement rules.
12. Pre-bid meeting will be held on 29.12.2025 at 10.30 AM in the office of the undersigned.
