- 2. The rates may be offered as %age above, %age below or At-Par on engineer estimate.
- 3. The bidder shall submit their bids on the following address "Executive Engineer, Hydrology Irrigation Division Warsak Road, Peshawar" only through reliable courier service on or before the deadline along with required documents as per details mentioned in Bid Solicitation Documents.
- 4. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority.
- 5. The bidder shall have the relevant codes as per Pakistan Engineering Council.
- 6. The bidder shall submit 02% bid security of the estimated cost, in the shape of Call deposit (Original) along with their bid before closing date and time in the name of Executive Engineer Hydrology Irrigation Division Warsak Road, Peshawar.
- 7. Non-refundable bidding entry fee @ 0.03% of the estimated cost in shape of Call Deposit separately may be furnished (in Original) to this office in the name of Executive Engineer, Hydrology Irrigation Division Warsak Road, Peshawar.
- 8. Notifications issued by Khyber Pakhtunkhwa Public Procurement Regulatory Authority pertaining to procurement process issued from time to time shall be applicable.

- 9. If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through toss.
- 10. Sealed Technical & Financial Proposals must be submitted as per guideness /instructions given in the Bid for work No.1.
- 11. The evaluation will be based on 70:30 basis i.e. 70% weightage will be given to technical and 30% weightage to Financial Proposals. Solicitation Documents shall be reach to the office of the Executive Engineer Hydrology Irrigation Division Peshawar before or on 20/01/2026 up to 12:00 pm through registered mail courier and only technical proposal of sub work No.1 will be opened at 12:30 pm on the same day by the tender procurement committee. In the presence of contractors/firms or their authorized representatives (who choose to be present).

Solicitation Documents shall be reach to the office of the Executive Engineer Hydrology Irrigation Division Peshawar before or on 20/01/2026 up to 12:00 pm through registered mail courier and will be opened at 12:30 pm on the same day by the tender procurement committee for work No.2. In the presence of contractors/firms or their authorized representatives (who choose to be present).

The technical proposals must contain full specifications of the equipment to be installed, name of the Manufacturer company/experience of the firm in supplying and Installation of such equipment, a certificate of Warranty of free maintenance/replacement of unserviceable parts in the defect liability period on the payment bases beyond defect liability period avoid holiday and gazetted holiday replacement of any damaged part as per given in the Bid solicitation Documents.
