- All bidders are requested to upload their bids (CDRs & Rate or Bid Documents in one PDF File) and submit through EPADS (<https://kp.eprocure.gov.pk/>) before the mentioned system closing time. Any Bid received without uploaded required documents (Copy of NIC, Enlistment with Govt: of KP, Pakistan Engineering Council, Kpra & FBR) will be treated as Non-Responsive.
- Electronic Bidding shall be done on "Above/Below" system on BOQ/Engineer's Estimate, based on MRS/NSI applicable. Only Two digits after the decimal point shall be considered for evaluation purpose.
- The Bidder shall submit their e-bids as per KPPRA Notification No. S.R.O. (13)/vol: 1-24/2021-22/6058-71, dated 10/05/2022.
- The Bidder shall submit the sealed bid with requisite documents including 2% Bid Security (or Additional security if required) of the estimate cost in the shape of call deposit (Original) before closing date and time through a Register Currier or Pakistan Postal Services. By hand No Bid of any Contractor Shall be acceptable.
- All the conditions/ instructions given in the bidding documents shall be applicable on all competitive bidders.
- Bid security of 1st, 2nd and 3rd lowest bidder will be released till approval of tender by the Competent Maturity.
- All the bidders, Firms must be register with Khyber Pakhtunkhwa Revenue Authority (KPR). In case of same rates quoted by the contractors, shall be decided through draw/Toss.
- A contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's estimated cost along with detailed rate analysis. If the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive.
- Call deposited of Schedule banks shall be acceptable. No Bank Cheque or Pay Draft shall be acceptable. Any Bidder who provides incorrect and false information shall stand disqualified and will be debarred.
- All the bidders are requested to download the bidding documents from the KPPRA website/Irrigation Department web site. (<https://irrigation.gkp.pk/>) of EPADS: (<https://kp.precure.gov.pk/>).
- All the prevailing KPPRA rules/Act and other Government Notification will be applicable issued from time to time & will become part of bidding documents.
- The Competent Authority has the authority to reject any bid or all the bids by giving cogent reason.
