TERMS/CONDITIONS;-

- 1) Bid solicitation documents contains requirements for eligible bidders and other important Terms & Conditions including instructions to Bidders can be downloaded from Irrigation website http://www.irrigation.gkp.pk/ as well as KPPRA website.
- 2) The bidders shall offer bids online and submit Bidding documents duly filled, signed and stamped alongwith original CDRs of the required amount which must reach the office of the undersigned upto the time/date mentioned below, otherwise bids offered will be considered as non-responsive.
- 3) Venue of Bid opening is the Office of Executive Engineer, Swabi Irrigation Division-II. Swabi.
- 4) Electronic Bidding shall be done on "Above/Below System" on BOQ/Engineer estimate, based on the MRS/NSI where applicable. Only two digits after the decimal point shall be considered for evaluation purpose.
- 5) The Employer has the authority to reject bid or all the bids assigning cogent reasons.
- 6) The KPPRA Notification No.SRO(14)Vol;1-24/2021-22/6058-71, dated 10/05/2022 & Notification No.SRO(15)Vol;1-25/2022-23/6301-13, dated 22/08/2022, and further amendments issued from time to time will be applicable.
- 7) As per KPPRA Notification, the Contractors/Firms who's bid is below 20% are bound to attach Additional original CDRs. The CDRs should be replaced by Bank Guarantee after Tender approval.

- 8) Bid security of the 1st, 2nd & 3rd lowest Electronic Bidders for the specific work will be retained by the Department for one week after issuance of letter of Acceptance to the successful bidders.
- 9) In case two or more Bidders offered the same Rate, successful Bidders will be decided through **DRAW**.
- 10) All the Bidders/Firms must be registered with the Khyber Pakhtunkhwa Revenue Authority.
- 11) All the prevailing KPPRA Acts/Rules updated instruction/Notifications and other Government Notifications issued from time to time will be applicable.
- 12) The Bidders/Firms must be Registered with the Pakistan Engineering Council (PEC) in the relevant Category and field of specialization for the works he has applied for.
- 13) The Registration/License of the Bidders/Firms must be Renewed from the Provincial Works Department for the year 2024-25
- 14) Mandatory conditions as per solicitations bidding documents (SBDs) will be adhered.
- 15) Pre-Bid meeting will be held on 18/02/2025 at 11.00 AM in the Office of Executive Engineer, Swabi Irrigation Division-II, Swabi.
