TERMS AND CONDITIONS

- 1. Electronic bidding will be online through EPADS-bidding system. Tender form and BOQ can be filled online and downloaded from the official website of Irrigation Department i.e. <u>www.irrigation.gkp.kp</u>, moreover a complete set of bid solicitation documents may be obtained by the contractor or their representative having valid authority letter on submission of written application from office of the undersigned in shape of Call Deposit (CDR) nonrefundable fees of 0.03% @ of estimated cost otherwise bid submitted without these documents will be considered as non-responsive.
- 2. The contractors quoting their bids up to a limit of 10% below Engineer estimate shall submit bid security @ 2% only of Engineer Estimate along with the stamp duty separately in shape of call deposit (CDR) in the name of procuring entity **(through courier)** before closing date and time otherwise it will be considered as non-responsive.
- 3. Electronic bidding shall be done on "above / below system" on BOQ / Engineer's estimate, based on MRS 2024 (1st BI Annual). Only two digits after the decimal point shall be considered for evaluation purpose.
- 4. Bidding documents can be downloaded from the official EPADS website (i.e., eprocure.gov.pk) after publishing the NIT. The BSD must be filled neatly, and a clear scanned copy of the same must be uploaded at the time of application (bid submission) through EPADS.
- 5. Cutting/overwriting/manipulation in the bid solicitation documents will not be acceptable. Any mismatch between the scanned copies submitted through EPADS and those submitted in hard form will lead to disqualification and the Contractor will be considered non responsive.

- 6. Bidder should submit their e-bids as per KPPRA Notification No.SRO(14)Vol; 1-24/2021-22 dated 10/05/20226058-71.
- 7. Complete details of the bid security in the shape of a CDR, i.e. Bank Name, CDR Number (s), and Date(s) must be submitted electronically along with the EPADS system.
- 8. The venue for bid opening is the office of the Executive Engineer Irrigation Division District North Waziristan, Miranshah.
- 9. All bidders are required to have valid registration with Khyber Pakhtunkhwa Revenue Authority established under the Khyber Pakhtunkhwa Finance Act, 2018 (Khyber Pakhtunkhwa Act. XXI of 2013).
- 10. Bid security of 1^{st,} 2nd and 3rd lowest bidder will be retained by the procuring entity till approval of the bid by the competent authority.
- 11. All Federal and Provincial taxes / duties shall be deducted from the bills of the contractors at prescribed rates as per Government Policy issued from time to time.
- 12. The bidders belonging to newly merged areas of tribal districts shall require to submit exemption certificate regarding Federal & Provincial Taxes / duties etc: from the concerned Federal / Provincial tax authorities on approval of their bids.
- 13. Any bidder who provided incorrect information shall stand disqualified as per KPPRA Act Section 29 (I) rule (43).
- 14. Successful bidders should sign the agreement with the Department within Twenty-Eight (28) days after acceptance of bid.
- 15. The procuring entity has the authority to reject any bid or all bids assigning valid reasons.
- 16. All the prevailing KPPRA rules / Act and other Govt. notifications will be applicable issued from time to time.
