Terms & Conditions for EPADS:-

(Documents and other queries may be clarified from the office in working hours or through EPADS Procedure)

1. Bids must be submitted electronically through EPADS on or before the prescribed date and time.
2. The bidder shall submit all required documents, including the original bid security, through a reliable courier service to the office of the Executive Engineer / Project Director, Irrigation Division South Waziristan Tank (Recharge Pakistan) on or before the specified deadline, strictly in accordance with the requirements of the uploaded RFP.
3. If the submission/opening date falls on a holiday or unforeseen circumstances, bids will be submitted / opened on the next working day at the same time and venue.
4. Incomplete, conditional, or non-compliant bids (including bids without the required bid security/additional security) shall be declared as non-responsive.
5. All Government Notifications/ rules / taxes implemented from time to time shall be applicable.
6. Any misrepresentation, false information, or submission of fake documents will lead to cancellation, blacklisting, and punitive action under relevant rules.
7. Each consultant may submit only one proposal; multiple submissions will result in outright disqualification.
8. Selection will be made under the Quality & Cost Based Selection (QCBS) Method (70% Technical, 30% Financial), as per KPPRA guidelines.
9. Technical and Financial Proposals must be submitted simultaneously but in separate sealed envelopes.

10. An Affidavit must be attached with the Technical Proposal confirming that the bid security is enclosed in the Financial Proposal envelope.
11. Any proposal received after the deadline will be returned unopened.
12. Consultants must submit: one original + two copies of the Technical Proposal and one original of the Financial Proposal, each clearly marked and sealed.
13. Each page of the proposal must be numbered, signed, and sealed by the authorized representative. Proposals must be staple-bound only; ring binding is not acceptable.
14. The Procuring Entity may revise TORs and evaluation criteria if deemed necessary, provided such changes are uniformly applicable to all bidders.
15. Any clarification must be sought in writing before the deadline specified in the Bid Solicitation Documents. No queries will be entertained thereafter.
16. Providing misleading or false information will result in rejection of the proposal and punitive action under applicable rules.
17. At least three (03) proposals must be received to ensure competition. If fewer than three proposals are received, the case shall be referred to the Client for decision in accordance with procurement rules.
18. The Procuring Entity reserves the right to reject any or all bids at any stage prior to acceptance, as per KPPRA Rule 47(1).
19. All notifications, circulars, and instructions issued by KPPRA regarding the procurement process, from time to time, shall be deemed applicable and binding on this bidding process.
