

4. The competent authority advised this office vide Superintending Engineer Swat Irrigation Circle Swat office letter No. 2431/28-M(Dir) Dated 19-12-2025 that "safeguard the department interest and compliance with procurement rules, cancellation of the subject tenders may be considered".

Keeping in view all of the above, the Procurement committee recommended the tenders for cancellation and re-tender please.






