

BID EVALUATION REPORT.

Name of work: - **Desiltation and other Annual Maintenance & Repair Works in Charsadda Irrigation Division Charsadda, During 2025-2026 (Civil Works).**

Sub-work:- **AM&R to Irrigation works in Utmanzai Section of Charsadda Irrigation Sub Division Charsadda during 2025-2026.**

1. The subject AM&R works was floated to tender in order to keep the AM&R contractor on board in case of any emergency work.
2. The Director Information was requested vide Executive Engineer, Charsadda Irrigation Division Charsadda letter No.980/CHD/6-M, dated 04/06/2025 to put the work for tender and also uploaded on KPPRA/Irrigation website. The Notice Inviting EPADS was published Daily Express Peshawar dated 07-06-2025, Daily Hashtnagar Charsadda dated 07-06-2025, Daily Siyaq Peshawar dated 11-06-2025 & Business Recorder Islamabad dated 07-06-2025 bearing No.INF (P) 2388/25.
3. On fixed date i.e **26-06-2025 till** specified time i.e **02.00 P.M**, only 05 Nos firm submitted their EPADS documents to Executive Engineer Charsadda Irrigation Division Charsadda office.
4. Electronic bid opening was carried out on the same day **26-06-2025 at 02.30 P.M** in presence of the procurement Committee notified vide Chief Engineer (South) Irrigation Department Peshawar letter No.247/C-3/KPPRA dated 01-02-2024 and contractors who desired to participate in the bid opening five **(05)** Nos firms quoted their bids through the online comparative statement.
5. The bids offered by the contractors through EPADS system in respect of the above mentioned sub work having estimated cost of **Rs.10.00 (M)** were accordingly evaluated by the procurement committee. The detail of evaluation is furnished as under.
