MINUTES OF THE MEETING OF TECHNICAL BID EVALUATION

A meeting of the Technical Bid Opening committee was held in the office of Executive Engineer, Irrigation Division, District Bajaur on 24-12-2024 in the presence of members of the committee notified by Chief Engineer (Merged Districts), Irrigation Department, Peshawar vide Notification No. 808/19-W, dated 13-05-2024 (copy enclosed) and the representative of the contractors who opted to participate / attend.

Head Clerk / Assistant, O/o the Executive Engineer, Irrigation Division, District Bajaur who was secretary of the committee informed the forum that above tenders were floated in the News papers on single stage two envelope system of bidding and several technical and financial bids have been received. He informed the forum that in the process of procurement, the technical bids shall be opened first and shall be evaluated by the notified committee. The evaluation report so prepared by the committee shall be submitted to the competent forum for consideration after which the financial bid of the technical approval / qualified bidders shall be opened while financial bids of technically failed / unqualified shall be returned to the not qualified bidders un-opened.

This meeting shall open the technical bids of the intending bidders. The committee was requested to open the technical bids of the prospective bidders which were opened one by one and signed by all present at the occasion.

The committee by opening the technical proposals announced publically the names of bidders who submitted the technical and / or financial bids, and any other document available therewith or enclosed therein the envelopes.

The secretary to the committee also presented a letter dated 24-12-2024 submitted by M/S Vector Engineering & Services and read it publically. The said bidder had requested to withdraw from the bidding process which was placed before the committee.

It was found and announced publically that M/S Wahid Builders did not submit the technical bid, however, its financial bid was found submitted.

After opening of the technical bids and affixing signatures of participants, the opened technical bids alongwith other documents were handed over to the technical bid evaluation committee for detailed evaluation, however, the sealed financial bids were handed over to the Secretary to the committee for keeping it under lock & key in his official custody.

Meeting ended with a note from and to the participants.
