**MINUTES OF DEPARTMENTAL CONSULTANT SELECTION
COMMITTEE MEETING HELD ON 4TH NOVEMBER, 2025**

A Departmental Consultant Selection Committee (DCSC) meeting was held on 04th November, 2025 under the Chairmanship of Secretary to Govt. of Khyber Pakhtunkhwa Irrigation Department at 10:00 hours, in the Committee Room of Irrigation Department Peshawar. List of participants as at (***Annex-I***).

In the meeting, the following item was discussed, detail is as under: -
