BIDS EVALUATION REPORT.

Name of Work:

CONSTRUCTION & RESTORATION OF FLOOD PROTECTION WORKS IN THALL, KUMRAT VALLEY IN KOHISTAN & USHERAI NULLAH, TRIBUTARIES OF PANJKORA RIVER IN DISTRICT DIR UPPER ADP No. 2098/250207(2025-026).

Sub Work:

Construction and restoration of flood protection works along Kohistan Nullah and its tributaries at vulnerable location from Kalkot to Pathrak in reaches in District Dir Upper.

1. The PC-I for the subject ADP scheme was approved at a total cost of Rs. 600 (Million) during the 10th PDWP meeting held on 08/01/2026. AA and minutes of the PDWP attached with the tender documents.
2. The approved PC-I comprises 8 No. sub-works falling within the jurisdiction of Dir Irrigation Division Dir with a total financial outlay of Rs. 600.00 Million. The subject sub-work, "Construction and restoration of flood protection works along Kohistan Nullah and its tributaries at vulnerable location from Kalkot to Pathrak in reaches in District Dir Upper." was approved with an estimated cost of Rs. 82.670 Million. (Abstract of PC-I attached with the tender documents).
3. A duly constituted Procurement Committee for procurement of works, goods and services, notified vide Chief Engineer (North) Notification No. 4074/C-I/KPPRA dated 11-12-2025, convened a meeting under the chairmanship of the Superintending Engineer, Swat Irrigation Circle, Swat, on 27/01/2026 at 02:00 PM. The Committee finalized the mode of procurement and reviewed the NIT and bidding documents. Minutes of the meeting attached with the tender documents).
4. Consequently, the Notice Inviting Bids (NIT) through Single Stage Single Envelope procurement method was advertised on EPADs, published in national dailies vide INF(P) No. 452/26 dated 01-02-2026, and uploaded on Irrigation Department & KPPRA websites. The closing date for submission of bids was 16/02/2026. Advertisement and related correspondence attached with the tender documents).
5. A total of 06 (Six) bidders submitted their bids through the EPADs system. The bids were opened by the Procurement Committee on 16/02/2026 at 02:00 PM in the

presence of intending bidders. During bid opening, the names of bidders, presence of bid securities in hard in sealed envelope, and quoted rates were announced.


6. The bids were evaluated by the Procurement Committee strictly in accordance with KPPRA Rules, NIT and Bidding Documents. The comparative statement of evaluated responsive bids is summarized below:

7. Due to identical lowest bids quoted by (02) bidder at 20% below the Engineer's Estimate, the bids were treated as lowest evaluated responsive bids. In accordance with the relevant provision of the NIT, the lowest bidder was determined through a draw conducted in the presence of the Procurement Committee and the concerned bidders. Consequently, the bid submitted by M/S Kumrat Construction Pvt Ltd village Maidan Patrak Tehsil Sheringal District Dir Upper, quoting 20% below on Schedule as well as Non-Schedule items, amounting to Rs. 66,136,000/-, has been determined as the lowest evaluated responsive bid. 


