19	The sealed bids submitted by the bidder were opened in the presence of the bidder/s/authorized representatives on the scheduled date and time. Attendance of the participants was duly recorded on the attendance sheet, which was subsequently uploaded on EPADS in accordance with KPPRA rules.																										
20	A total of eighteen (18) bids were received. After detailed examination of the bidding documents, ten (10) bidders were found responsive, while the remaining bidders were declared non-responsive due to non-compliance with the bidding requirements. All ten (10) responsive bidders quoted identical rates at 20% below premium on both Schedule and Non-Schedule items.																										
21	Based on the Fair draw conducted by the Procurement Committee, M/s Nawab Zada, Government Contractor, was declared as the successful/lowest evaluated bidder.																										
22	The evaluated bid amount of Rs. 21.416 million, being 20% below premium, against the Engineer's Estimated Cost of Rs. 26.77 million, quoted by M/s Nawab Zada, Government Contractor was found to be reasonable and recommended by the Procurement Committee for approval of the competent authority vide Superintending Engineer, Swabi Irrigation Circle letter No. 574/6-M/1, dated 18.11.2025 (Annex-V).																										
23	The Bid Evaluation Report was discussed under the chairmanship of the Chief Engineer (North), Irrigation Department, on 16.12.2025, to deliberate upon the observations raised and correspondence exchanged between the Procuring Officer and the Procuring Entity.																										
24	Consequent upon the transfer of Engr. Muhammad Zubair, Superintending Engineer, Swabi Irrigation Circle, the Procurement Committee for Swabi Irrigation Circle was reconstituted, appointing the Superintending Engineer, Swat Irrigation Circle, as Chairman vide Notification No. 4136-A/C-1/KPPRA dated 16.12.2025, to function until the regular posting of the Superintending Engineer, Swabi Irrigation Circle. (Annex-VI).																										
25	The reconstituted Procurement Committee reviewed the earlier evaluation and found the recommendations to be justified, transparent, and in accordance with KPPRA rules.																										
26	In view of the above, the Procurement Committee recommends that the lowest evaluated bid of Rs. 21.416 million @ 20% below premium on Schedule and Non-Schedule items, submitted by M/s Nawab Zada, Government Contractor, being responsive to the conditions laid down in the NIT and bidding documents, for approval of the competent authority under the Khyber Pakhtunkhwa Delegation of Financial Powers Rules, Third Schedule (Special Powers), Section-11, S. No. 02.
