Name of Work: **ADP No.2123/250802 - Construction of Flood Protection Works in Upper and Lower Dir.**  
Sub Work: **Construction of Flood Protection Works along Lift Side Panjkora River from Danwah to Shagoo Kass and its Tributaries in reaches District Dir Lower.**

1. ✓ The PC-I for the subject ADP scheme was approved for a total cost of Rs. 1000.00million during the PDWP meeting held on 16/02/2026. AA and minutes of the PDWP attached as **Annex-I**.
2. The approved PC-I comprises 18 No' sub-works falling within the jurisdiction of Dir Irrigation Division Dir with a total financial outlay of Rs. 1000.00million. The subject sub-work, "Construction of Flood Protection Works along Lift Side Panjkora River from Danwah to Shagoo Kass and its Tributaries in reaches District Dir Lower." was approved with an estimated cost of **Rs. 96.44 million**. Abstract of approved PC-I attached as **Annex-II**.
3. A duly constituted Procurement Committee for procurement of works, goods and services, notified vide Chief Engineer (North) Notification No. 4074/C-I/KPPRA dated 11-12-2025, convened a meeting under the chairmanship of the Superintending Engineer, Swat Irrigation Circle, Swat, on 10/03/2026 at 02:00 PM. The Committee decided to adopt the single stage Two Envelope bidding method for above Sub-Work . Minutes of the meeting attached as **Annex-III**.
4. Consequently, the Notice Inviting Bidding through Single Stage Two Envelope Procurement Method on EPADs was advertised in the National Dailies / Press vide **INF(P) 214/26 Dated 18-03-2026** and was also uploaded through Irrigation Department Website & KPPRA website, with last date for submission of technical & financial proposals as 13/04/2026 (12:00 noon). Copy of letter to Director information and published NIT attached as **Annex-IV**.
5. 23 (Twenty-Three) No.bidders submitted their bids through the EPADs system. Screenshot of EPADs showing applicant bidders is attached as **Annex-V**.
6. The Technical bids were opened by the Procurement Committee on 13/04/2026 at 12:30 PM in the presence of intending bidders. Attendance sheet of bidders attached as **Annex-VI**. During technical bid opening, the names of bidders, presence of affidavit of 2% bid security in financial envelop, non-Blacklisting and non-litigation affidavit were announced.
7. The technical proposals were scrutinized by the Procurement Committee for initial checking of the mandatory requirement requirements in accordance with the NIT Bidding Documents. The detail is tabulated as under:


