3. The Notice Inviting Tender was published in Daily Newspaper, Peshawar vide INF(P) 1060/26 and also uploaded on the Irrigation Website. (Copy attached as **Annex-III**).
4. Bid soliciting / bidding documents comprising of evaluation criteria for technical bids were uploaded on the Irrigation Department Website for downloading by the intending bidders.
5. Procuring Committee for bid opening and evaluation was constituted vide Chief Engineer (Merged Districts) Irrigation Department Peshawar letter No. 669/19-W, dated: 29/05/2025 (Copy attached as **Annex-IV**).
6. On the stipulated date and time, i.e., 02.04.2026 at 12:30 pm the technical bids were opened on EPAD in the presence of Bid opening committee, 06 Nos. contractors submitted their technical bids on EPAD.


