**Terms & Conditions**

1. Bid Solicitation documents including instruction to bidders can be downloaded from Irrigation Department website: [www.irrigation.gkp.pk](http://www.irrigation.gkp.pk).
2. Bid security @2% of the estimated cost in shape of Call deposit (original) from scheduled banks in the name of Executive Engineer, Irrigation & Hydle Power, Division Kurram must be accompanied with bidding documents sealed in envelop which should reach to the office of undersigned through courier/representative before closing date and time.
3. The bidders are required to quote their rates ABOVE/BELOW on BOQ/Engineer's estimate both on MRS as well as non-MRS items. First two (02) digits after decimal will be considered for evaluation.
4. In case of bid / rate quoted by the bidder more than 10% Below Engineer Estimate, the Additional Bid Security shall be provided by the successful bidder only to the extent of the bid more than 10% Below the Engineer Estimate in the form of percentage. The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% Below Engineer Estimate.
5. In such eventually, the successful bidder shall be bound to produce the Additional Bid Security within 03 working days from the issuance of Letter of Acceptance, failing which Bid Security of successful bidder shall be forfeited and legal proceeding will also be initiated against the bidder who repudiated the contract under KPPRA Procurement Rules.
6. All Bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority (KPPRA), established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for the works, consulting and non-consulting services as listed in Schedule-II of the Act ibid.
7. The bidder belonging to Merged Tribal Districts of Khyber Pakhtunkhwa shall be required to submit exemption certificate regarding Federal/Provincial Taxes/duties from the concerned Federal/Provincial tax authorities on approval of their bids.

8. If the evaluated electronic bid costs of two or more bidders are equal then the successful bidder will be declared through draw.
9. If any document submitted along with bids is found false / bogus the registration of the Contractor / Firm shall stand cancelled / black listed.
10. Venue of bid opening is Irrigation & Hydle Power, División Kurram at Parachinar that will be open in the presence of the contractors or their representatives, who opt to attend.
11. The contract will be offered to the next lowest bidder after due diligence in the context of financial difference between such two bids and the market analysis in order to discourage cartel making and to protect public interest at large.
12. All Federal and Provisional Taxes/duties levied from time to time shall be recovered from the contractor's bill as per government policy.
13. All the prevailling KPPRA rules/Act and other Govt notification issued from time to time shall be applicable.
14. Bid Security of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> lowest bidders will be retained by Executive Engineer for seven (07) days after contract agreement with successful bidder.
15. If the performance bond or bank guarantee (which ever the case may be) is not provided by the bidder in the required period the bid security of the defaulting bidder will be forfeited.
16. The payment will be subjected to availability of funds.
17. Successful bidders should sign the agreement with the department within twenty eight (28) days after acceptance of bid.
18. Pre-bid meeting will be held on 30-3-2021 at 10:00 am in office of the undersigned, the prospective bidders may attend the meeting.
19. The Competent Authority reserves the right to accept / reject any or all the bids at any time prior to acceptance of a bid as per Para 47(i) of KPPRA Rules 2014.
