NOTICE INVITING E-BIDDING

Irrigation Department Govt. of Khyber Pakhtunkhwa intends to undertake the Electronic Bids of “Single Stage Single Envelope System with Post Qualification method, Rule No.17 of KPPRA Rules 2014, for which bids are invited from the eligible Government Contractors / Firms enlisted with Irrigation Department who have renewed their enlistment and valid PEC License in Relevant Category for the following Works:

TERMS AND CONDITIONS:

1. The interested Contractors / Firms are required to provide Technical Proposal comprising information regarding Experience, Personnel Capabilities, Financial Status, Equipment Capabilities and other relevant information as explained in the Bid Soliciting Documents (one original + one copy) in sealed envelopes & the Financial Proposal in separate envelope containing the Bid Security in Original @ 2% of the estimated cost in the shape of Call Deposit from scheduled banks, copies of valid PEC Registration & Irrigation Department Enlistment. Any proposal or Bid for which the bid security and Brouchers containing technical details are not received shall be considered as non-responsive and their financial bid shall not be considered. **(Financial & Technical bids must reach on or before 01-02-2022 at 12:00 Noon.**
2. The Financial Bid shall be submitted electronically through **E-Bidding System of Irrigation Department**, not later than above specified date & time.
3. Bid Soliciting Documents containing Instructions to Bidders, Technical Evaluation Criteria, advertisement for Notice Inviting Bids and required forms to be filled by the bidders can also be downloaded from the official website of Irrigation Department Khyber Pakhtunkhwa (www.irrigation.gkp.pk).
4. The Financial bids of the qualified bidders approved by the Competent Authority shall be opened by the notified committee on **08-02-2022 at 12:30 PM** in the presence of Contractors / Firms or their authorized representatives who choose to attend. In case of any unforeseen reasons, public holiday, unrest or force majeure on the bid opening dates the same shall be opened on the next working day at the same place & time.
5. The contractors quoting their bids up to a limit of 15% below Engineer estimate shall submit bid security to the extent of 2% of Engineer Estimate only.

6. The contractors quoting their bids more than 15% below on Engineer's Estimate shall submit along with their bids, an **Additional Security** to the extent of their bid / rates more than 15% below on engineer estimate in the form of percentage.
7. In case the bidder quotes more than 15% below the Engineer Estimate and the bid is not accompanied by the Additional Security then the bid shall be considered as non-responsive and the 2nd lowest bidder and so on will be considered accordingly.
8. In case a contractor quotes more than 30% below on Engineer Estimate, the procuring entity shall, in addition to additional security, require the contractor to produce detailed rate analysis of his bid price in relation to any or all the items of bill of quantities, scope of work, allocation of risks and responsibilities and/or any other requirements of the bid solicitation document. The contract shall be awarded to the lowest evaluated bidder who has satisfied the procuring entity on rate analysis. However, if the procuring entity determines that the contractor has failed to demonstrate its capability to execute the contract at the offered price, the matter shall be referred to the next higher authority for rejection of the bid on the basis of being financially unviable.
9. All the Bidders are bound to follow the instructions content KPPRA Notification **No.S.R.O.(13)/Vol:1-21/2021-22, dated 15-09-2021.**
10. The bids shall be quoted on “%age Above / Below System” on BOQ/ Engineer's Estimate.
11. The Competent Authority reserves the right to accept/reject any or all bids at any time prior to acceptance of a bid as per Para 47(i) of KPPRA Rules 2014.
12. Call Deposits of only scheduled Banks shall be acceptable. **No Bank Cheque or Pay Order shall be acceptable.**
13. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority (KPRA).
14. **Bid Securities of 1st, 2nd & 3rd lowest bidders shall be retained till signing of the Contract Agreement with the lowest responsive bidder.**
15. All the prevailing KPPRA Act / Rules and other Government Notifications issued will be applicable.
16. Pre -Bid meeting would be held in the office of the undersigned on **25th January 2022 at 11.00 AM.**
17. Contractors / Bidders would have to include the BOQ showing the Sales Tax bifurcation details (duly filled) (received vide KPPRA Notification No.S.R.O (10)/Vol:1-18/2020, dated 10-02-2021) provided in the Bidding Documents along with Call Deposit & other requisite documents in the Financial Bid Envelope. In case of its non submission, bids would be considered as Non-Responsive.
