

The bidder shall submit their bids on the following address "Administrative Officer, O/O Chief Engineer (South), Irrigation Department, Warsak Road, Peshawar" only through reliable courier Service on or before the deadline along with required documents as per details mentioned in Bid Solicitation Documents. The affixed labels of the Courier Service provider may be authenticated for tracking before opening. Fake courier delivery shall be processed as per the law and would not be considered.
4. All bidders are required to have valid registration with Khyber Pakhtunkhwa Revenue Authority.
5. The bidder shall submit 02% bid security of the estimated cost as mentioned above, in the shape of deposit at call (Original) enclosed along with their bid before closing date and time in the name of Executive Engineer, Warsak Canals Division Peshawar.
6. Notifications issued by Khyber Pakhtunkhwa Public Procurement Regulatory Authority pertaining to procurement process issued from time to time shall be applicable.
7. If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw/toss.
8. Pre-Bid meeting will be held on 21-12-2022 at 11.00 A.M in the Conference Room of the Chief Engineer (South), Irrigation Department, Warsak Road Peshawar.
