4. All the conditions / instructions given in the bidding documents shall be applicable on all competitive bidders.
5. The bids will be valid for one hundred & twenty days (120) from the bids opening.
6. The bid security upto 3rd lowest bidder will not be released till approval of tender by the competent authority.
7. Call Deposit of Scheduled Banks shall be acceptable. No Bank cheque or pay order shall be acceptable.
8. All the bidders are requested to download the bidding documents from the KPPRA website & www.irrigation.gkp.pk.
9. Pre-bid meeting will be held on **05/08/2022** in the office of the undersigned at 12.00 Noon.
10. All the bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act 2013(Khyber Pakhtunkhwa Act No.XXI of 2013).
11. All the prevailing KPPRA rules / Act and other Govt: notifications will be applicable issued from time to time & will become part of bidding documents.
