

1. Bid Soliciting Documents containing Instructions to Bidders, Terms & Conditions, advertisement for Notice Inviting Bids and required forms to be filled by the bidders can be downloaded from the official website of Irrigation Department Khyber Pakhtunkhwa ([www.irrigation.gkp.pk](http://www.irrigation.gkp.pk)).
2. The bidders should submit their E-bid as per KPPRA Notification No.SRO (14)-Vol/1-24/2021-22, dated 10-05-2022.
3. All Bidders are required to have valid Registration with Khyber Pakhtunkhwa Revenue Authority established under the Khyber Pakhtunkhwa Finance Act 2018 (Khyber Pakhtunkhwa Act, XXI of 2013)
4. The Competent Authority reserves the right to accept/reject any or all bids at any time prior to acceptance of a bid as per Para 47(i) of KPPRA Rules 2014 by assigning cogent reason.
5. The interested Firms/Contractors may obtain clarification regarding bid solicitation documents during office hours on any working day from the office of Executive Engineer, Chitral Irrigation Division, Chitral.
6. Venue of Bids opening is office of the Superintending Engineer, Swat Irrigation Circle Saidu Sharif Swat however, the Contractors must prepare their CDR's i.e. 2% Earnest Money and Additional E/Money (if any) in shape of call deposits only in the name of Executive Engineer, Chitral Irrigation Division, Chitral and should ensure its submission with their bids. In case of failure their bids would be rejected and punitive action should be initiated against the defaulter as per KPPRA Act / Rules.
7. Bid must be received in the relevant office through courier services or TCS agencies.
8. In case of identical lowest responsive bids, the successful bidder would be decided through Toss.
