**Terms & Conditions for E-Bidding:-**

- Bid Solicitation Documents containing all the terms and conditions and other relevant instructions for works can be downloaded from the department and or KPPRA websites ([www.irrigation.gkp.pk](http://www.irrigation.gkp.pk)) / ([www.kppra.gov.pk](http://www.kppra.gov.pk)).
- The Contractors/ Firms must have the PEC Category EE11 for the participation in the tendering process.
- Bid Solicitation Documents contains mandatory requirements to be fulfilled in order for bidder to be eligible to participate. The Bidders are required to agree to all terms and conditions of bidding documents.
- The Bidder shall submit their bids through leading courier service on or before the deadline along with required documents as per detail mentioned in the bid solicitation documents.
- Venue of Bid opening is office of the Superintending Engineer, DIKhan Irrigation Circle DIKhan.
- The bidder are required to quote their rates above or below on BOQ both on MRS as well as Non MRS components.
- 02% Bid security / Earnest Money + Stamp duty + Tender Fees of the estimated cost from the account of firm / bidder / contractor who submit the bid must be accompanied with the tender document/ quotation through any scheduled bank in favor of **Executive Engineer, Paharpur Irrigation Division DIKhan**. Failure to submit the 2% CDR will lead to rejection of the bid.
- The bidders who quote their bids / rates more than 10% below on Engineer's Estimate shall submit along with their bids additional security as per KPPRA Notification SRO No. (14)/VOL-1-24/2021-22 dated 10-05-2022
- If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw / toss.
- The employer has the authority to reject any or all the bids assigning cogent reasons.
- Bid security of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> lowest bidders will be retained by the employer for at least one week after issuance of letter of acceptance to the successful bidder.
- As per clause 37 (A) KPPRA Rules, All bidder are required to have registration with Khyber Pakhtunkhwa Revenue Authority.
- All the prevailing KPPRA Acts/ Rules and other Govt Notification will be applicable, issued from time to time.
- Funds release depends upon policy of Provincial Govt, hence payment will be made accordingly. Bidder/ Contractor agreeing with the financial constraints in respect of payment etc are at liberty to participate in the instant E-Bidding as no claim whatsoever will be entertained in this regard.
- Last Date / time of submission of tenders Forms on 20/3/2023 at 1:00 P.M and will be opened on same date in office of the Superintending Engineer, DIKhan Irrigation Circle DIKhan.
- All Govt: Notifications/ Rules/Taxes updated from time to time shall be applicable.
- The work quantity may decrease due to financial constraints or as the case maybe.
