- 7. The bidders who quote their bids / rates more than 10% below on Engineer's Estimate shall submit along with their bids additional security as per KPPRA Notification SRO No. (14)/VOL-1-24/2021-22 dated 10-05-2022
- 8. If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw / toss.
- 9. The employer has the authority to reject any or all the bids assigning cogent reasons.
- 10. Bid security of 1st, 2nd and 3rd lowest bidders will be retained by the employer for at least one week after issuance of letter of acceptance to the successful bidder.
