

- 5. The participating bidders must submit their updated FBR (Active system) KPPRA (Active status)
- Electronic bidding shall be done on "Above/Below" on BOQ/Engineer Estimate based on the MRS/NSI where applicable. Only two digits after the decimal points shall be considered for evaluation

The employer has the authority to reject any bid or all the bids by assigning cogent reason.

- All the bidders, Firms must be register with Khyber Pakhutunkhwa Revenue Authority. In case of same rates quoted by the contractors, the lowest bidder shall be decided through draw/Toss.
- 12. All the prevailing KPPRA Acts/rules/updated instructions, notification and other Govt: notifications will be applicatble issued from time to time.
- 13. All the contractor/Firms shall pay Govt: Taxes including Income Tax, Sales Tax, Profissional Tax, Stamp duty etc as per Govt: notification circulated from time to time.
- 14. Successful bidder should sign Agreement with Deptt: withing 14 days after receipt of acceptance letter.
- 15. A contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's estimated cost equal to the differential amount of submitted bid and Engineers' Estimate along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Government and the 2nd lowest bidder and so on will be considered accordingly. The additional security shall be released to the contractor in 04 installment i.e ist instalment of 25% to be released upon completion of 25% of the project. 2nd installment of 25% upon completion of 50% of the project. 3rd installment of 25% of 75% of the project and 4th installment of 25% after 100% completion/handing over the project.
- 16. All such efforts conpire to curtain making shall be considered as violation of rules 44 and shall be attributed toard mis-procurement under rules 54 procurment rules.
