TERMS AND CONDITIONS

- 1. Bidding documents and instruction to bidders & all details can be downloaded from Irrigation Department Web site (www.irrigation.gkp.pk) or from the E-PADS website (www.eprocure.gov.pk).
- 2. As per KPPRA notification No. SRO.(23)Vol:1-23/2024-25 dated 24/03/2025/1575 security shall be submitted by the bidders as under:
- 3. The Contractor quoting their bid more than 10% below on Engineer Estimate shall submit bid security to the extent of 2% of Engineer Estimate only.
- 4. The Contractor quoting their bid more than 10% below up to 20% below on Engineer Estimate shall submit along with their bid 8% Additional Security of Engineer Estimate cost in addition to 2% bid security if the bid is not accompanied with required amount of additional security then it will be considered as non-responsive and the 2% bid security be forfeited in favor of government and the second lowest bidder and so on will be considered accordingly.
- 5. Similarly a contractor quoting bid more than 20% below shall submit with this bid an additional security on Engineer Estimate cost equal to the different amount of submitted bid and Engineer Estimate along with detail rate analysis. In case of more than 20% below bids it the bid is not accompanied by the detailed rate analysis and / or required amount of additional security then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of government and the second lowest bidder and so an will be considered accordingly.
- 6. In case detailed rate analysis submitted with the bids is in view of the procuring entity not convincing. The head of the procuring entity may declare such bid as non-responsive without any forfeited of bid securities of bid securities and record reason thereof.
- 7. The procuring entity may offer the contract to next lowest bidders after due diligence in the context of financial difference below such two bids or may advertise procurement opportunity afresh.
- 8. If evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw/toss.
- 9. Bid shall accompanied with 0.03% of E/Cost as tender entry fee in shape of separate CDR Which is non-refundable.
- 10. Pre-bid meeting will be held on 08-10-2025 at 11:00 am in office of the undersigned, the prospective bidders may attend the meeting.
