1. All bidders are requested to upload their bids (CDRs & Rate or Bid Documents in one PDF File) and submit through EPADS (<https://kp.eprocure.gov.pk/>) before the mentioned system closing time. Any Bid received without uploaded required documents (Copy of NIC, Enlistment with Govt: of KP, Pakistan Engineering Council, Kpra & FBR) will be treated as Non-Responsive.
2. Electronic Bidding shall be done on "Above/Below" system on BOQ/Engineer's Estimate, based on MRS/NSI applicable. Only Two digits after the decimal point shall be considered for evaluation purpose.
3. The Bidder shall submit their e-bids as per KPPRA Notification No. S.R.O. (13)/vol: 1-24/2021-22/6058-71, dated 10/05/2022.
4. The Bidder shall submit the sealed bid with requisite documents including 2% Bid Security (or Additional security if required) of the estimate cost in the shape of call deposit (Original) before closing date and time.
5. All the conditions/ instructions given in the bidding documents shall be applicable on all competitive bidders.
6. Bid security of 1st, 2nd and 3rd lowest bidder will be released till approval of tender by the Competent Authority.
7. All the bidders, Firms must be register with Khyber Pakhtunkhwa Revenue Authority (KPRA). In case of same rates quoted by the contractors, shall be decided through draw/Toss.
8. A contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's estimated cost along with detailed rate analysis. If the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive.
9. Pre bid meeting will be held on 24-09-2025 at 12.00 PM in the office of the undersigned.
10. Call deposited of Schedule banks shall be acceptable. No Bank Cheque or Pay Draft shall be acceptable.
11. Any Bidder who provides incorrect and false information shall stand disqualified and will be debarred.
