- Accordingly the work was put to EPADS vide this office letter No.1697/CHD/6-M, dated 18/09/2025 and also uploaded on KPPRA/Irrigation website. The Notice Inviting EPADS was published Daily Wahdat Peshawar dated 23-09-2025, Daily Aaj Peshawar dated 23-09-2025, Daily Hashtnagar times Charsadda dated 23-09-2025, Daily Awam-Un-Nas Peshawar dated 23-09-2025 & Dawan Peshawar dated 23-09-2025 bearing No.INFP 3990-25.
- On fixed date i.e 09-10-2025 till specified time i.e 02.00 P.M, only 09 Nos firm submitted their EPADS documents to this office.
- Electronic bid opening was carried out on the same day 09-10-2025 at 02.30 P.M in presence of the procurement Committee notified vide this office letter No.1735/CHD/6-M, dated 24/09/2025 and contractors who desired to participate in the bid opening twelve (12) Nos firms quoted their bids through the online comparative statement.
- The bids offered by the contractors through EPADS system in respect of the above mentioned sub work having estimated cost of Rs.4.40 (M) were accordingly evaluated by the procurement committee. The detail of evaluation is furnished as under.

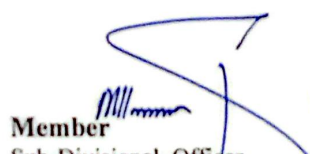
