

4. The bidder shall submit 02% bid security, of the estimated cost as mentioned above, in the shape of deposit at call (Original) along with their bid before closing date and time. In case of non receipt of Call Deposit before closing time the same shall be considered according to KPPRA Notification No.SRO(29)/Vol:1-40/2025-26, dated.29th October 2025.
5. The bidder shall submit 02% bid security, of the estimated cost as mentioned above, in the shape of deposit at call (Original) along with their bid before closing date and time. In case of non receipt of Call Deposit before closing time the same shall be considered according to KPPRA Notification No.SRO(29)/Vol:1-40/2025-26, dated.29th October 2025.

8. Notifications issued by KPPRA pertaining to procurement process issued from time to time shall be applicable.
9. If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw/toss.
10. Bid security of 1st, 2nd and 3rd lowest bidders will be retained by the employer till the approval of bids by the competent authority.
