10 The evaluated bid amount of Rs. 0.48 million, being 20% below premium, against the Engineer's Estimated Cost of Rs. 0.60 million, quoted by M/s Zab & Brothers Government Contractor was found to be reasonable and responsive to the conditions mentioned in the NIT/Bidding Documents.

11 In view of the above, the lowest evaluated bid of Rs. 0.48 million @ 20% below premium on Schedule and Non-Schedule items, offered by M/s Zab & Brothers, Government Contractor, is hereby recommended by the Procurement Committee in light of the Khyber Pakhtunkhwa Delegation of Financial Powers Rules, Third Schedule (Special Powers), Section-11, S. No. 02, please.
