11										The evaluated bid amount of Rs. 0.44 million, being 20% below premium, against the Engineer's Estimated Cost of Rs. 0.55 million, quoted by M/s Lets Build Construction Co. Government Contractor was found to be reasonable and responsive to the conditions mentioned in the NIT/Bidding Documents.	
12										In view of the above, the lowest evaluated bid of Rs. 0.44 million @ 20% below premium on Schedule and Non-Schedule items, offered by M/s Lets Build Construction Co., Government Contractor, is hereby recommended by the Procurement Committee for approval of the Competent Authority in light of the Khyber Pakhtunkhwa Delegation of Financial Powers Rules, Third Schedule (Special Powers), Section-11, S. No. 02, please.
