8	The sealed bids submitted by the bidders were opened in the presence of the bidders/authorized representatives on the scheduled date and time. Attendance of the participants was duly recorded on the attendance sheet, which was subsequently uploaded on EPADS in accordance with KPRA rules.															
9	A total of Seven (7) bids were received. After detailed examination of the bidding documents, only (06) bidders were found responsive. The six (06) responsive bidders quoted identical rates at 20% below premium on both Schedule and Non-Schedule items.															
10	As per NIT Condition No. 07, which states that "In case of same rates quoted by the bidders, the lowest/successful bidder shall be decided through draw," The Procurement Committee conducted a draw in a transparent manner.															
11	Based on the draw conducted by the Procurement Committee, M/s Javid & Brother, Government Contractor, was declared as the successful/lowest evaluated bidder.															
12	The evaluated bid amount of Rs. 0.52 million, being 20% below premium, against the Engineer's Estimated Cost of Rs. 0.65 million, quoted by M/s Javid & Brother Government Contractor was found to be reasonable and responsive to the conditions mentioned in the NIT/Bidding Documents.															
13	In view of the above, the lowest evaluated bid of Rs. 0.52 million @ 20% below premium on Schedule and Non-Schedule items, offered by M/s Javid & Brother, Government Contractor, is hereby recommended by the Procurement Committee for approval of the Competent Authority in light of the Khyber Pakhtunkhwa Delegation of Financial Powers Rules, Third Schedule (Special Powers), Section-11, S. No. 02, please.
