Sub Work: **Restoration / Rehabilitation of Roads and Crossing Facilities in PK-08 Tehsil Matta District Swat.**


1. The work "Restoration / Rehabilitation of Roads and Crossing Facilities in PK-08 Tehsil Matta District Swat" was approved in DDWP meeting held on 12.11.2025 for an estimated cost of Rs. 180.0 Million (minutes of the meeting issued vide Letter No. PMC/DDWP/2025-26, dated 26.11.2025 Enclosed as **Annexure A**).
2. The work having estimated cost of Rs.178.61 (Million) was put to E-tender through EPADS and E-Publicity via KPPRA & Irrigation websites and in Daily Newspaper Mashriq Peshawar, dated 26-11-2025 vide INF(P) 4997/25. (Enclosed as **Annexure B**).
3. As per scheduled mentioned in the N.I.T i.e 19-12-2025 (1:30 PM), 24 Bids through EPADS system were received as per schedule given in the NIT condition. Electronic bids of the contractors were opened in the presence of Procurement Committee members and Contractors / their representatives, whose sealed bids / CDR were received, (EPADS system electronically generated statement along with attendance Sheet are enclosed as **Annexure C** and **Annexure D** respectively)
4. The bids offered by the contractors through EPADS in respect of the above-mentioned work & whose sealed bids / CDR received accordingly, were evaluated by the Procurement notified vide Letter No. 4074/C-1/KPPRA, dated 11.12.2025 (Enclosed as **Annexure E**), The detail of evaluation is as under:




