1. The work "Construction and Rehabilitation of Kabal Gram and Bihar Martung Irrigation Channel District Shangla. (ADP N0. 2116/250235) "was approved in DDWP meeting held on 12.11.2025 for an estimated cost of Rs. 250.00 million minutes of the meeting issued vide Letter No. PMC/DDWP/2025-26, dated 26.11.2025 (Enclosed as Annexure A).
2. The Sub work having estimated cost of Rs.94.051 (Million) was put to E-tender through EPADS and E-Publicity via KPPRA & Irrigation websites and in Daily Newspaper Mashriq Peshawar, dated 26-11-2025 vide INF(P) 4997/25. (Enclosed as Annexure B).


