

BID EVALUATION REPORT

Name of work: - Feasibility Study and Construction Revamping of Kalpani nullah /Rustam Khwar via Kallang for flood Resilience and flood infrastructure in District Mardan (ADP # 2127/251204) (2025-26)

- The PC-I for the subject ADP scheme was approved at a total cost of Rs.500.00 Million in 16th: PDWP meeting held on 12/03/2026. Administrative Approval & Minutes of the PDWP attached as (Annex-I)
- The approved PC-I comprises **13 Nos:** Sub Works falling within the jurisdiction of Mardan Irrigation Division, Mardan with a total financial outlay of Rs.500.00 Million. The subject sub-work, **"Construction of flood protection works in Kalpani nullah for the protection of village Abadies and agricultural land at village Sikandari in District Mardan"**, was approved with an estimated cost of Rs.15.010 Million. (Abstract of PC-I attached as Annex-II)
- A duly constituted Procurement Committee for procurement of works, goods and services, notified vide Chief Engineer (North) Notification No. **4074/C-I/KPPRA, dated 11-12-2025**, convened a meeting under the chairmanship of the Superintending Engineer, Mardan Irrigation Circle, Mardan, on 15/04/2026 at 10:30 AM. The Committee finalized the mode of procurement and reviewed the NIT and bidding documents. Minutes of the meeting attached as (Annex-III)
- Consequently, the Notice Inviting Bids (NIT) through Single Stage Single Envelope procurement method was advertised on EPADs, published in national dailies vide INF(P) No. 2584/26 dated 04-06-2026, and uploaded on Irrigation Department & KPPRA websites. The closing date for submission of bids was 15/06/2026 (10:30 AM). Advertisement and related correspondence attached as (Annex-IV)
- A total of **03 Nos:** bidders submitted their bids through the EPADs system. The bids were opened by the Procurement Committee on 15/06/2026 at 11:00 AM in the presence of intending bidders. During bid opening, the names of bidders, presence of bid securities in hand in sealed envelope, and quoted rates were announced.
- The bids were evaluated by the Procurement Committee strictly in accordance with KPPRA Rules, NIT and Bidding Documents. The comparative statement of evaluated bids is summarized below:
