**Feasibility Study and Construction Revamping of Kalpani nullah /Rustam Khwar via Katlang for flood Resilience and flood infrastructure in District Mardan
(ADP # 2127/251204) (2025-26)**

- 1 The PC-I for the subject ADP scheme was approved at a total cost of Rs.500.00 Million in 16th: PDWP meeting held on 12/03/2026. Administrative Approval & Minutes of the PDWP attached as (Annex-I)
- 2 The approved PC-I comprises **13 Nos:** Sub Works falling within the jurisdiction of Mardan Irrigation Division, Mardan with a total financial outlay of Rs.500.00 Million. The subject sub-work, "Construction of F.P.W in Kalpani nullah for the protection of village Abadies and agricultural land at village Pump Koroona, Herawand and Kanda Janday in District Mardan", was approved with an estimated cost of **Rs.52.402 Million. (Abstract of PC-I attached as Annex-II)**
- 3 A duly constituted Procurement Committee for procurement of works, goods & services, notified vide Chief Engineer (North) Notification No.**4074/C-I/KPPRA, dt: 11-12.2025**, convened a meeting under the chairmanship of the Superintending Engineer, Mardan Irrigation Circle, Mardan, on 15/04/2026 at 10:30 AM. The Committee finalized the mode of procurement and reviewed the NIT and bidding documents. Minutes of the meeting attached as (Annex-III)
- 4 Consequently, the Notice Inviting Bids (NIT) through Single Stage Single Envelope procurement method was advertised on EPADs, published in national dailies vide INF(P) No. 2584/26
- 5 A total of **02 Nos:** bidders submitted their bids through the EPADs system. The bids were opened by the Procurement Committee on 15/06/2026 at 11:00 AM in the presence of intending bidders. During bid opening, the names of bidders, presence of bid securities in hard in sealed envelope, and quoted rates were announced.
- 6 The bids were evaluated by the Procurement Committee strictly in accordance with KPPRA Rules, NIT and Bidding Documents. The comparative statement of evaluated bids is

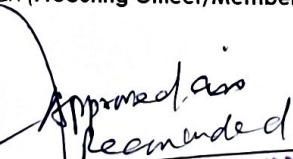
