3. Tender / bids have been called on single stage single envelope system of procurement of KPPRA Rules 2014.
4. Bid soliciting documents together with instruction to bidders & BOQ were uploaded on the procuring entity as well as KPPRA websites to be downloaded by the intending bidders.
5. On stipulated date and time in the office of the Executive Engineer, Swabi Irrigation Division-II Swabi 16.9.2020 bids of 14 participants were received.
6. As per schedule mentioned in the E-bidding System, bids were opened on 16.9.2020 in the presence of the Bidders, Firms and their representatives who cared to attend.
